The applicant proposes to modify the existing Ludlow Mills Building 44 with associated site improvements. Associated site improvements include, but are not limited to, the construction of two (2) new parking lots to service Building 44, in addition to the construction of a new stormwater management system.

The Committee reviewed comments from the Town Planner, Building Commissioner and Conservation. DPW, Fire and Police were present are were part of the discussion.

Angela Tierney from Conservation had many questions on the project which was already in the beginning stages. The project did not go through Conservation for any Conservation Commission determinations. Angela had concerns that the applicant did not receive any filings for this project, but that work had started. The project is in close proximity to the riverwalk and the Chicopee River.
