October 1, 2019

The Meeting of the Board of Selectmen held on Tuesday, October 1, 2019 began at 6:00 p.m. in the Selectmen's Conference Room, Town Hall.

#### **Visitations:**

## Shawn Ryan Howe, American Legion Post 52 Commander

Mr. Howe discussed seeking the Board's approval for the American Legion Post 52 parade route for the 100-year Anniversary Celebration to be held on a weekend in August 2021; the use of the roads; and nominating a Board member to be on the parade committee.

Mr. Howe is in the process of discussing various parade routes with the Police Chief, Fire Chief and the Director of the Department of Public Works. Mr. Howe stated passing the memorial on East Street would be included in the parade route and anticipates this parade would be larger than the annual Memorial Day parade. Mr. Howe stated he will also be asking the Veterans' Agent, Eric Segundo to be a part of parade committee.

Chairman DeBarge stated he is an American Legion Post 52 member. Chairman DeBarge also stated his concerns are the date in August to be chosen; the heat of August; and the use of first responders during the tight window between Celebrate Ludlow and the start of school. Mr. Howe stated August was chosen since Post 52 will be turning 100 on August 21, 2021.

Mr. Silva moved and seconded by Mrs. Fernandes to approve the parade to be held by American Legion Post 52, use of the roads in 2021, and nominated Chairman DeBarge to be on the parade committee. Vote 4-0-1 abstention.

238. Michael G. Suprenant, P.E. – Temporary Director of Public Works/Town Engineer – requesting the Board of Selectmen to approve the proposed classification and rate changes for a second mechanic position.

Mrs. Villano stated Carrie Ribeiro, Director of Human Resources also provided an email with her recommendations. Mrs. Villano stated the DPW is recommending adding a second mechanic in case the regular mechanic is out. Mrs. Villano stated the primary mechanic also does field work and plows if needed. Mrs. Villano stated the recommendation from Human Resources is to make two heavy equipment labor/mechanics, a primary and a secondary. Mrs. Villano stated the mechanic is out and they hired another individual. Mrs. Villano stated when the mechanic comes back, there should be two positions that are the heavy equipment labor/mechanics. Mrs.

Villano stated there is no change in the rate of pay; it will help the DPW function better; there is a vacancy; and the DPW wants the position reclassified to a mechanic. LERK'S OFFICE

Moved by Mrs. Fernandes and seconded by Mr. Silva to approve the proposed slassification and rate changes for a second mechanic position as discussed for both parties contingent on the Union approving the first party. Vote 5-0 all in favor.

Mrs. Villano confirmed the Board is approving the change as outlined by the Human Resource Manager changing both the mechanic position and this vacant position to be two Mechanic/Heavy Equipment pending acceptance or approval by the Union to change the description of the current mechanic position.

Mrs. Villano stated the Board of Selectmen can only change the temporary compensation for an Engineering Intern. Mrs. Villano stated the DPW is looking to change the compensation plan for an Engineering Intern from \$14.42 to \$16.98. Mrs. Villano stated the DPW recommendation is that the position be compensated the cost of living annually is not recommended by Human Resources because these are temporary positions over a finite period of time and has often been vacant over the years.

Moved by Mr. Silva and seconded by Mrs. Fernandes to change the compensation plan for a Senior Engineering Aid (Temp) position from \$14.42 to \$16.98 and periodically review. Vote 5-0 all in favor.

239. Pablo P. Madera, Chief of Police – informing the Board of a liquor law violation that occurred at the Gremio Lusitano Club on August 23, 2019.

Mr. Silva disclosed he is a Board of Director for the Gremio Lusitano Club; will not participate on any votes but would like to be a part of discussions. Mrs. Fernandes, Mr. Goncalves and Mr. Rosenblum disclosed they are members of the Gremio Lusitano Club.

Mr. DeBarge read the letter he received from Chief Madera regarding a liquor law violation that occurred at the Gremio Lusitano Club on August 23, 2019.

Moved by Mr. Goncalves and seconded by Mr. Rosenblum to schedule a hearing with the Gremio Lusitano Club Manager; a representative of their Board; Chief Madera; and Active Detective Sgt. Kornacki. Vote 4-0-1 all in favor.

For the Board's information: The Massachusetts Department of Elementary and Secondary Education has informed us the state funded legislative earmark is being issued out as a grant in the amount of \$100,000 for the replacement of the Ludlow High School track. We must apply for it through their grants management system (EdGrants) in order to receive these funds.

Mrs. Villano stated the school has applied through the State's EdGrants system for the \$100,000 for the replacement of Ludlow High School track. Mrs. Villano stated she had a discussion with Senator Lessor's Chief of Staff to see if this is a multi-year grant or if the funds need to be used by the end of the fiscal year on June 30.
