**6:15 p.m. – Robert's Auto Body Sales Public Hearing Class II – Change of Address.**

Moved by Mr. Silva, seconded by Mr. Rosenblum to open the public hearing at 6:15 p.m. for Robert's Auto Body Sales for Class II license. Vote 3-0. All in favor.

Mr. DeBarge: Mr. Kopec, how are you? Good to see you again. Okay so we are here for a change of address. All of the I's have been dotted and T's have been crossed, you have been vetted with your abutters, planning, safety and...

Ms. Villano: The three letters are there, I forget. The Building Commissioner.

Mr. DeBarge: The Building Commissioner, so change of address.

Mr. Silva: Do we have a site plan at all, did you bring the site plan at all?

Mr. Kopec: Yes, there was two of them because there was an increase for the numbers. I believe it is just under 30, somewhere around there.

Mr. Silva: 30 cars you are applying for.

Mr. Kopec: Currently we have a 5 car from Carmelina's.

Mr. Silva: And your adding...

Mr. Kopec: Which obviously this parking lot is drastically a lot bigger. Just a little bit bigger.

Mr. Silva: I think I know because Carmelina's is.... Okay so this one here actually adds more because that one only has 22. So, this one here you have actually put in all your spots in it okay and your application is for 30.

Mr. Kopec: Yeah that's fine.

Mr. Silva: That's what you are here for. Is that what is on the app?

Ms. Villano: I don't have the application, the application is....

Mr. Silva: This one doesn't have enough so. It doesn't show enough on there so you know.

Mr. Kopec: Right, I think this is what the Planning Board had me do just to say okay let's do this for now and if you want more cars talk to the Board of Selectmen, discuss that at the meeting. So, this was just so they went off of this just to say yes, he's good to go and then he said, they told me to address it with you guys.

Mr. DeBarge: Okay.

Mr. Silva: Do you have the application?

Mr. Kopec: Thank you.

Mr. Silva: I still don't see the number.

Ms. Villano: It would have to be on his application.

Mr. DeBarge: I didn't see it either.

Mr. Silva: Because the number is actually going to go on his license.

Ms. Villano: You can do this based on your conversation.

Mr. Silva: We want to make sure we do the right number because then when we have Police Officers check and so on if he's over his limit you know it gets convoluted.

Resident: Yes, my question is as far as the, not so much the auto sales part but it is the auto sales part too because originally, I thought this was just an auto repair place or an auto body all right. But my main

concern on this is that he was in a able to go in and clear this whole thing, cut down all the trees all right and I abut behind so I have had my yard flooded multiple times and I know he did some precaution for that all right but my main concern now is he is going to have wrecked cars in there with oil leaking and everything else, anti-freeze. So, I don't want this stuff in my yard, if we happen to get a monsoon of rain, because I already have video of it flooding my yard all right and I showed the Building Department on it. All right and my biggest concern is of oil and anti-freeze running in my yard. I have a coy pond down there that got flooded out once already because he cut all the trees down. So, and then I have to look at unsightly vehicles because originally when I talked to the Building Department, he promised to put up a stockade fence to at least take the unsightly vehicles away all right. And I have to live with my wife every single day complaining about this.

Mr. DeBarge: That's not easy.

Resident: No, it's not so and my biggest concern more so is the fact of that if we do get a heavy rain there is no way his little retention pond, holding pond is going to stop all the water with oil and anti-freeze from running in my yard. At least the trees with the natural cover did deter to slow down because I have been this almost 30 years and I never had a problem when Metras was there. So, with the zoning change for now cars opposed to an electric company, I have a major concern and it's sad that I am the only one here but.

Mr. DeBarge: All right.

Mr. Kopec: You asked me to cut those trees down.

Resident: No, I did not Marek, I did not ask you to cut the trees. The only thing I said was because there was one leaning into my garage, was the only one I was ever going to say cut it down and I was going to send before I even knew Metras sold because when I first moved in Metras cut all the trees down. Not every single one but there was one leaning. I never, ever said for you to cut all of these trees down.

Mrs. Kopec: There were people there that heard the comments as well and we said it's going to cost more....

Mr. Kopec: With all do respect is this meeting about cutting trees or is it about...

Mr. Silva: No, no, no.

Mr. Kopec: Okay.

Mr. DeBarge: But he is allowed to make a comment.

Resident: But besides of all of the trees my main concern is how is he planning on stopping the oil for one thing and anti-freeze because I know when.....

Mr. Kopec: So those vehicles are on the other side of the building they are not even next to his building, they are right on the side of Poppi's Pizza.

Mr. Silva: Mr. Chairman.

Mr. DeBarge: Yes.

Mr. Silva: Your concerns are fair; however, they really don't pertain to the issues of the license. Your concerns are more to do with the Planning Board....

Resident: But this is more of the.....

Mr. DeBarge: Hang on sir, let him finish.

Mr. Silva: Making sure that he complies with whatever the Planning Board issued for his operation and making sure. Now as far as the oils, totally illegal as far as any oils leaking, anything leaking on properties and so on. So, that is something that is I don't think that's something that he wants to have done because that....

Mr. Kopec: We have been towing for the Town of Ludlow since early 90's so we understand.

Mr. Silva: He just said now that the vehicles will be on the other side so they don't, they would be probably, I haven't seen the parcel or where they are going to be but it's probably impossible to get to your property if any leakages are there. But he is going to have to contain that for sure. I got to say as far as....

Resident: Well I can tell you right now if it does run in my yard, I will be getting a lawyer and I will be suing Roberts.

Mr. Silva: Absolutely and that's your right. But as far as the other things that you mentioned and there is supposed to be a fence there and the Planning Board issued that with a fence, then the fence has to go up. So, they are the ones that are going to police the so-called site plan improvements that he has to do. As far as us, we really can't...

Resident: No, I know but I just figured I had some sort of shot here okay.

Mr. Silva: Yes.

Resident: Because a I never had a voice to begin with as far as everything else that was...

Mr. Silva: Yeah, that's the unfortunate thing with work, umm living next to you know industrial property, commercial property and so on. Their rights....


Mr. Silva confirmed there will not be a Board of Selectmen meeting on March 31<sup>st</sup>.
