Miscellaneous:

Board discussed when the Senior Abatement program will resume. The program has been on hold since the COVID-19 pandemic but now seniors and some departments have been asking when it will resume as it has to be complete by December 31st. Ms. Villano explained that the schools are closed and essentially a volunteer would be working alone if they were to volunteer at the school. The library is partially open and potentially a volunteer could work with a limited amount of people there as well. The issue is most of these volunteers are in the 'high risk' category for the virus.

Mr. DeBarge asked which departments had asked about the Senior Abatement Program resuming.

Ms. Villano explained that the School Department, Vets services and Golf had inquired.

Mr. Rosenblum asked for a list of where the volunteers would be used and suggested doing it on a case by case situation.

Mr. Silva suggested to wait a month and revisit it. The Board was in agreement with that.

Closing Comments:

Mr. Rosenblum congratulated Mr. Silva on being the new Chairman and also thanked and congratulated Mr. DeBarge. Stated that Mr. DeBarge did an exemplary job through an unprecedented time. Congratulate everyone during the elections held yesterday and congratulate Mr. Goncalves for being reelected and encourages people to get involved. The local voting was up to 18% from 10% the previous year.

Mrs. Fernandes congratulate all the new candidates. Mrs. Fernandes explained how difficult running a campaign is and she also congratulated Mr. DeBarge for being such a great Chairman during a very difficult time. She also stated that the Track and Field question was defeated at the polls and encouraged them to try again in the future when the Town budgets are a little better.

Mr. Goncalves also thanked Mr. DeBarge and stated that he will be a tough act to follow. He also congratulated the class of 2020 and even though they missed out on the celebrations this is a lesson for the future that everything isn't always peachy all the time. Congratulations to all of the elected officials and those who have concluded their service. He encourages people to become precinct members, the Town is in need of these people. He reminded people to continue to wear masks and social distance when possible.

Mr. DeBarge thanked everyone who came out to vote and was impressed with how many residents who did vote. Congratulations to all of the winners. Congratulations to the class of 2020, I was able to watch the parade of the seniors and it was a great experience. This class could not participate in the traditional proms and graduations, but they got through it with class. Mr. DeBarge thanked Ms. Villano and all of the department heads for making his job as Chairman very easy. The Board of Selectmen spoke with the Chief of Police before today's meeting about possible riots in the surrounding town and cities because of the tragic death of George Floyd. He encouraged residents when they go out to keep their head on a swivel. There has been riots in Boston and Springfield and just wants everyone to be vigilant out there.

Mr. Silva congratulated the Town Clerk for the elections and how smooth they went. Congratulated Mr. Goncalves for his 3-year appointment to the Board of Selectmen. Encourages the Track and Field Committee to keep moving forward with donations and at least get the track fixed and usable. Congratulations to the seniors!

Moved by Mr. DeBarge, seconded by Mr. Goncalves to adjourn this meeting at 6:56 p.m., not return to open session. Vote 5-0. All in favor.
