Board to appoint Ken Batista and Jim Goodreau as "Trench Permit Authority".

Moved by Mr. DeBarge, seconded by Mr. Rosenblum to appoint Ken Batista and Jim Goodreau as "Trench Permit Authority". Vote 3-0. All in favor.

Selectmen DeBarge to discuss a Covid-19 testing site to be held in Ludlow.

Mr. DeBarge stated he was approached by Sheriff Nick Cocchi about the idea of bringing a COVID-19 testing site to our community for residents and town employees only. Mr. DeBarge stated the Operations Manager of American Medical Response (AMR) from Springfield would collaborate with Sheriff Cocchi's staff to set up a drive-up testing site at Hampden County Correctional Center on Tuesday, December 22. Mr. DeBarge stated AMR would conduct the tests and provide the results before Christmas to those Ludlow residents and town employees who pre-register. Mr. DeBarge stated there would be no charge to residents or town employees. Mr. DeBarge stated AMR and our Board of Health would do the contact tracing for any positive cases. Mr. DeBarge stated the balance we have in our CARES Act money is enough to pay for the tests and AMR staff, however he is awaiting confirmation from our consultant that the CARES Act money can be used for this. Mr. DeBarge stated this expense is not coming from the town's budget.

Moved by Mr. Rosenblum, seconded by Mr. DeBarge to endorse the COVID-19 testing site project to be held at the Hampden County Correctional Facility and authorize the Town Administrator to enter into and sign the necessary contracts with American Medical Response (AMR) as needed, if the CARES Act money can be used as payment. Vote 3-0. All in favor.

Closing Comments:

Ms. Villano stated the Chairman of the Board of Public Works provided an update regarding the "no commercial" signs. Ms. Villano stated a traffic study needs to be done. Mr. Santos informed Ms. Villano the Pioneer Valley Planning Commission will be submitting all the necessary paperwork to the State and it is moving forward.

Mr. DeBarge asked about the mirror being installed on Old West Street. Mr. Silva advised Mr. DeBarge to contact the Safety Committee.
