# 5:30 - Continued Liquor License Hearing - Transfer of Liquor License from Turnpike Package to Ludlow Liquors:

Mr. Rosenblum: We have a continued Liquor License hearing transfer of liquor license from Turnpike Package to Ludlow Liquors and on the phone, we have Attorney Levine. How are you this evening Attorney Levine?

Attorney Levine: I'm doing fine. Thank you for having me again.

Mr. Rosenblum: Thank you for calling back in. I understand that you have a change right now.

Attorney Levine: Unfortunately, the applicant has to withdraw the application as we discussed at the last one you granted a continuance. I was waiting on some documents that would...ABCC approval. Two tax claim certificates, we gave ourselves some time to get them but unfortunately, they still have not been forthcoming and I don't know when or if those will be available and so at this time, we withdrawing the application.

Mr. Rosenblum: Okay.

Mr. Silva: Mr. Chairman.

Mr. Silva: Yeah, Attorney Levine, is there any, I know you said you don't know how long it's going to be but is there any time frame that you think it might possibly be or because what I'm, I'm, to close the hearing we'd close it and then have to reopen the whole thing again. Mr. Rooney: Introduced Kevin Lauer, Board of Directors of the Ludlow Country Club and the Chairman of the 100<sup>th</sup> Anniversary Committee.
