#### **Visitations**

Colin E. Galindo Firefighter/Paramedic Interview

Mr. Galindo introduced himself.

Mr. DeBarge: What would your former chiefs/captains tell you your best quality is or what you need to work on?

Mr. Galindo: My best attribute is being dedicated to the job, hardworking, learns something new every day. My worst attribute is the medical side of the field. I dwell, on not having the answer in the moment.

Mr. Rosenblum: What do you see as your own personal weakness?

Mr. Galindo: My personal weakness is borderline obsession of wanting to be perfect, always looking back at what I did wrong and what I could have done better.

Mr. Silva: Can you describe a traumatic experience whether in your field of work or personally and how did you handle it?

Mr. Galindo: Working in Springfield there's calls that you get that will either make you or break you as a person. You need to do the job well because things you are exposed to in the city, multi car accidents with deceased victims, having to transport them. That day you may ask why, but you go in the next day because of the desire to have great outcomes for the patients.

Mr. Goncalves: I love your ambition of having two jobs; is the idea of getting this one and leaving the other two?

Mr. Galindo: The idea is having some idea of the fire schedule. Being a new paramedic in this field, I just would like to keep that scale because it really is something you don't get to do often working in AMR. Even though not every single call is acute, but the chance for OT is there every single day; the chance to do something good. It's really just keeping the class up to a standard that I would want my mother to be treated with.

Mr. Goncalves: Before 2019 what did you do before you got into ambulances?

Mr. Galindo: Before working in EMS, I was working at Westover Airforce Base as a telecommunications technician for two years and before then also at Westover Airforce Base as roads and ground keeping for a year.

Chief Pease: Mr. Galindo was a student of AMR. It finally opened up after Covid when he was able to ride various shifts with the Ludlow paramedics. All feedback from different paramedics was very positive. With his experience at AMR and South Hadley, I believe we are getting a good one, a good decision here.

Mr. Galindo: I'm happy for the opportunity and overjoyed to have the potential to work in the town that I live in and grew up in.

Moved by Mr. DeBarge to appoint Colin E. Galindo to the Ludlow Fire Department effective immediately, seconded by Mr. Silva. Vote 4-0

Exit 7 Players – Discuss Lease Agreement

Christina Donnoly from Agawam and Vice President of Exit 7, along with Adam Malmborg from East Longmeadow and President of Exit 7 introduced themselves to the Board. They had concerns with what the Board's intentions were with the space located at 37 Chestnut Street. They understand the Housing Authority owns the building and the lease is with them. Adam has been in touch with Robin of the Housing Authority and our current lease expired in June. They wanted to know what the next step is.

Mr. Rosenblum: The Board of Selectmen spoke to Robin a few weeks ago and mentioned that we wanted them to meet with you and figure out what work's best for both of you. Exit 7 is a great asset to the community.

Mr. Goncalves suggested to go ahead and discuss it with Robin and see where you end up.

Mr. Rosenblum: Mr. Strange do we want to put a motion first of all to extend the lease probably about three months, usually we retroactive to July 1<sup>st</sup> because we will have to do something with that.

Mr. Strange: Our year lease with Ludlow Housing Authority is contingent upon sealing off the boiler that's in the Ludlow Housing Authority building from heating the other two buildings. We met with corporate out there and it sounds like it's not that big of a deal so I think we'll be able to do that soon. Once that is effectuated, then we can get out of the nine-year lease. We really have no rights or obligations in the building. I think it will be less than three months but three months just to be safe.

In order to do that, we need to change the charter and have a different form of government.
