
MINUTES OF THE MEETING OF THE LUDLOW HOUSING AUTHORITY March 19, 2020 11:00 am

3. Payment of the Bills- Warrant report



A. February 29, 2020 Report 109.4% Reserve and Net Income \$201,607 Numbers are inflated due to sale of (2) off-line houses that were sold. Once they are replaced proceeds from homes will be used decrease the net income and reserve.

- B. (4) Floods, All repairs complete. All tenants back in their apartments. Now waiting for reimbursement from Insurance company, to see what our out of pocket damages will be.
- C. Boiler at New Wilson in building #6 is being funded through our CIP. Revision made.
- D. We have (3) vacant apartments: One is being rented for April 1, 2020, One apartment is for a tenant being transferred (due to major structural floor repairs), and One is a FISH for tenant damages, should be completed by April 30, 2020. We will be receiving (4) more units in April.

5. Modernization Report:

- A. Offline Houses: FISH # 161075: entered in Purchase & Sale of 236 Center Street. All inspections have been completed and waiting for results.
 Next Bid opening is scheduled for March 27, 2020 at 11:10 a.m.
- B. PHN 2019-13 Technical Assistance for Vacant Land Development: Meeting cancelled. It will be rescheduled after State of Emergency lifted
- C. FISH # 161103. Waiting for Town to cut/trim their portion and then we will complete the rest.


6. Reading of the Correspondence:
